**2026/2 Planning Applications**

a. None to note

**2026/3 County Borough Council matters**

Previously reported

- a. Nothing has been done about the footpath at Heol Y Graig. The fence that EDS removed and replaced has not been put back in a good state.
- b. Grit boxes were requested but these have not been received.
- c. Lights are still not working between 12-16 Heol y Bryn.
- d. There is a fallen tree resting on a branch of another tree on the Glynneath bank just at the first layby on RCT side.

### **New Matters**

- a. The state of the road from where they resurfaced the road past the school up passed Heol Pendarren is in a dreadful state and needs replacing.
- b. There are potholes along the highway between the Plough and junction of Smiths Avenue. Lots of erosion of the tarmac along the gas main trench and needs to be resurfaced.
- c. There are potholes on Heol Pendarren road and also the drains are completely blocked.
- d. The drains between Werfa Rhigos road and Plasnewydd Rhigos Road are blocked and the water is bubbling over the top.
- e. Parish road, the verges of the road need to be cut back but nothing has been done since Cllr. Morgan reported this months ago. If RCT want to acknowledge it is a livre carriageway then they need to take action and cut back the overgrowth on the roadside.
- f. The bus stop sign is missing at the Plough Cwmhwnt.
- g. Please can we have an update on the green fencing by the village shop opposite Min Afon.
- h. Hirwaun Industrial Estate needs attention, general maintenance, potholes and litter picking. It a forgotten place and big companies are paying lots of business rates.
- i. GN Rhigos road, the drains are overflowing and need cleaning again and a litter pick.
- j. The school guttering needs to be kept clear otherwise the building will deteriorate.
- k. There have been lots of complaints about the food bags and recycling bags that they are too thin and tearing. The Council have gone back to the older type bags so this should no longer be an issue.
- l. There are potholes in Heol Esgyn between no's 22 and 24. The pavements need attention. Adam will check if this is due for resurfacing and if not he will report.
- m. RCT are monitoring the fly tipping on the Glynneath Bank.
- n. The sign at Min Afon has been knocked over. Can it be reinstated please.
